

# Central Avenue celebration showcases NRP at work

One of the primary functions of the NRP is to increase collaboration between community stakeholders. In fact, some of the most far-reaching NRP-sponsored projects have resulted when neighborhoods, government and businesses have joined forces in developing and implementing plans aimed at benefiting entire communities.

Nothing exemplifies this better than the work that is now being done along Central Avenue in northeast Minneapolis. Residents and businesses in the area are so excited about the improvements that are being made to the thriving corridor that they came together for a block party celebration on August 29.

Perhaps the most visible of the new Central Avenue improvements are the 95 new low-level pedestrian scale street lights that span from 18th to 27th avenues NE. The lights create a safe, walkable environment as they wrap around each block to link Central to rear parking areas. In addition, a new Crime Prevention Through Environmental Design (CPTED) program has also been launched. The program focuses on reducing crime by designing or redesigning the physical and natural environment along Central.

Four neighborhoods, Holland, Windom Park, Logan Park, and Audubon Park invested \$327,000 of NRP funds in the Central Avenue lighting project.

# In Brief

## Training for Neighborhood Organizers

Neighborhood organizations are increasingly facing challenges that require having skilled organizers on staff. In order to assure that these organizers are equipped with the skills they need to do their jobs effectively, a special training program is now being offered by the Minneapolis Training Program for Neighborhood Organizers (MTPNO). This training program is geared toward assisting organizers with the complex problems facing their specific neighborhood organizations.

The program will combine comprehensive coverage of organizing basics, trainings tailored to the individual needs of each organizer and group, long-term followthrough, and group support from fellow neighborhood organizers. The training program will last up to six months, and is composed of the following parts:

**INITIAL INTENSIVE TRAINING** will concentrate on providing organizers with the nuts and bolts of organizing. The initial training will take eight hours a week over four weeks. Six hours a week will be spent in group trainings, and two hours a week will be spent in doing neighborhood outreach. Topics covered include:

- Leadership development
- Issues identification
- Grassroots and foundation fundraising
- Organizing under-represented groups
- Volunteer recruitment
- Running meetings and events
- Research
- Media and communication

**WEEKLY INDIVIDUAL MEETINGS** will be scheduled with each organizer to discuss and analyze the projects and challenges facing his/her neighborhood. These sessions can last up to one-and-a-half hours.

**MONTHLY GROUP MEETINGS** of the program's participating organizers will allow for the sharing of experiences. These meetings will last up to two hours.
