

## NRP board approves \$4 million for seven affordable housing projects

The NRP Policy Board took a lead role in addressing the city's affordable housing shortage on March 25 by approving nearly \$4 million to be invested in seven projects that will create or renovate 195 units of affordable housing. Combined, the seven projects will leverage an additional \$33 million in private and public financing and will include the production of another 104 market rate units.

The projects were approved to receive NRP funding through the program's Affordable Housing Reserve Fund established last year to demonstrate the NRP's commitment to developing long-term affordable housing for individuals and families that earn less than half of the Metro Median Income.

A description of each of the approved projects follows.

• Jeremiah Program - \$1 million approved for a 21-unit expansion of an 18-unit residential facility for low-income single mothers and their children in the Loring Park neighborhood.

- Volunteers of America Senior Housing \$624,000 approved for construction of a 51-unit mixed-income, mixed-use senior housing development in the Holland neighborhood.
- Olson Towne Homes \$555,000 approved to rehabilitate a 92-unit scattered-site housing development built in 1956 near Olson Memorial Highway in the Harrison neighborhood.
- East Phillips Commons \$515,000 approved for construction of 32 units of mixed-income, mixed-use housing in the East Phillips neighborhood.
- Village in Phillips \$360,000 approved for construction of 28 units of mixed-income, mixed-use housing in the East Phillips neighborhood.
- Lamoreaux Apartments \$400,000 approved for construction of a three-story, 39-unit addition to the existing three-story Lamoreaux Apartments in the Downtown West neighborhood.
- Lofts on Arts Avenue \$490,000 approved for construction of 36 units of loft-style owner-occupied housing on a four-lot site in the Stevens Square neighborhood.

### Neighborhood Information System awarded U.S. Department of Commerce grant

The Minneapolis Neighborhood Information System (MNIS) was recently awarded a \$500,000 grant from the U.S. Department of Commerce's National Telecommunications and Information Administration. The grant was one of 74 Technology Opportunity Program (TOP) grants totaling \$42.8 million awarded to nonprofit organizations and state and local governments across the United States and Puerto Rico.

MNIS is a joint project of the NRP, the Center for Urban and Regional Affairs (CURA), the City of Minneapolis and several participating Minneapolis neighborhood organizations. The project provides detailed housing information and analysis to help neighborhood organizations plan and evaluate housing improvement strategies and programs as well as assists them in a variety of community planning efforts. The MNIS partners plan to use the award to create an integrated property database system that will give neighborhoods real-time internet access to basic housing information as well as problem property indicators such as code violations, delinquent property tax status and utility arrears. Neighborhoods will be able to incorporate local data with city and county data and produce maps of past and current housing programs, housing conditions and areas at risk. These tools will allow neighborhood organizations to track the health of their neighborhoods' housing supply and target resources and strategies for addressing housing deterioration problems accordingly.

### Minneapolis says goodbye to longtime neighborhood activist Shirley Murzyn

The Columbia Park neighborhood lost an activist and a good friend when Shirley Murzyn died February 16, 2002, from injuries sustained in an automobile accident. Shirley was one of the four residents who founded the Columbia Park Neighborhood Association (CPNA) in 1988. She was elected to the first CPNA Board that same year and had served as a member of the board until her untimely passing.

The goals of the CPNA include developing a sense of community, encouraging maximum participation in neighborhood decision making and facilitating neighborhood improvements. With Shirley's help, the neighborhood has accomplished these goals and more. Shirley served as CPNA's treasurer for many years while the neighborhood's NRP plan was being implemented. She helped assure that housing was improved, sidewalks were built, intersections were made safer, the Cargill site was transformed into a gateway and community garden site and the Columbia Park playground was renovated. Shirley was especially proud of the playground renovation. She and her husband Ed often recounted how the park's equipment was old when their children were young. The couple finally saw their efforts for a new playground become a reality in 1988 when their children were in their forties. Shirley's persistent and tireless work made the neighborhood a great place to live and raise children.

Friends of Shirley's children remember her as a good neighbor. They say her door was always open and that she listened – really listened – and shared in their trials and triumphs. She continued to share their good times and bad for the entire 40 plus years that they knew her.

Shirley will be remembered most for her smile and for her

love for her husband, Edward. The two were a team. They served on the board together and they went to church together. Ed drove Shirley to her job as a health unit coordinator at Hennepin County Medical Center. She told fellow board members that they should appreciate their husbands. "You never know how much time you'll have together," she said. "You should enjoy the hours together that you do have."

How true. We did not expect to lose her so soon and suddenly. We mourn the loss of our good friend and neighbor.

# Upper River Citizens Advisory Committee seeks 10 additional members by April 12

A new 30-member Upper Mississippi River Citizens Advisory Committee (CAC) is now forming. This broad-based group will play a unique role in implementing the city's "Above the Falls" master plan, especially in the areas of policy, funding allocation, project approval and communications. The master plan area extends from Plymouth Ave. /8th Ave. NE to the north city limits on both sides of the river. Already 20 members have been selected through a grassroots neighborhood-oriented process and will convene for the first time soon. The CAC, which will select the remaining 10 members, is soliciting applications for those positions. Of the IO remaining members, eight will be representatives from neighborhoods not immediately adjacent to the Upper River area; one will be a business representative and one will be an environmental representative. There will be two alternates for every member.
